Outdoor Bowls

The Outdoor Bowlers President has raised questions around some operational issues. Currently the Raglan Club opens the Bowling Club bar 3.30 - 5.30 (or longer if people are continuing to socialise) on Wednesdays and Saturdays for rollup. We also open the bar for twilight bowls and tournaments at no charge. Opening the bar at other times incurs a fee as we don't know how many people will be there and if costs will be covered. The bowlers have been asked if they have any other suggestions for how the Club can cover costs when opening for events outside the usual, the main club is open for bowlers to use.

Non bowlers wanting to book the bowling club facility and play bowls, pay a reduced hireage fee for the bowling club for up to 2 hours as they pay the outdoor bowlers \$10 per person (min \$100) to hire the bowls. The Club has done this to make it affordable for guests, however due to recent confusion and bowlers not wanting to leave when others have booked the facility, there will not be a reduced hireage fee.

Other maintenance issues will be addressed.
