### **General Business.**

- AGM and conference is in March in Wellington,

- Brian will get pricing for the mural if we decide to go ahead with it at the front
- Due to a series of floods into the building over the years, the last one in November, the floor and ceiling is very damaged. We have dried out the building previously but the latest flood has been the final straw and damaged the dance floor that is used for indoor bowling. We have a quote to repair that is in excess of \$120,000 not including carpet or unforeseen issues. Debbie met with the insurance assessor who has approved the claim, subject to reports. Once we get these we can plan how to address repairs.

- The same people are doing the raffles and announcements every week. We need to discuss rostering all the committee on or paying people to do it. To be discussed when the full committee is in attendance.
