We continued to invest in our facilities, delivering tangible improvements that have enhanced both the look and feel of the Club. Highlights include:

- Floor repairs completed
- Bathroom upgrades completed
- New asphalt surfaces
- Doug Ford's award-winning mural, which proudly earned the Resene Professional Mural of the Year

These upgrades help create a more welcoming and functional space for members and visitors alike.

### Financial Year in Review

This past year marked our **first financial loss since 2017/18**, when I became President. However, this was **planned and budgeted** — after several years of saving, we reinvested into the Club to secure its future.

Key factors affecting the bottom line:

- A 3-week closure in June for essential floor work impacted bar and restaurant income.
- Staffing challenges, especially over the **Christmas period**, limited our ability to fully benefit from the busy season.
- Management turnover added operational strain and increased costs.

Despite these hurdles, we are **well-positioned** moving forward — with new leadership in place and a strong team driving us ahead.

# Investing in the Future

Looking ahead, we've taken smart steps to strengthen our long-term sustainability:

### Solar Power Installation

Already saving the Club thousands — and will easily pay for itself in 6 years, considering rising energy costs and added usage from our new cabins.

# **✓** Passive Income from Cabins

We now have **three rentable cabins** in the carpark generating steady income, thanks to the hands-on work of Glenn Rangitonga.

# **Leadership Transition**

After 7 ½ years as President, I'll be stepping down — but I'm not going far. I'll continue serving the Club as **Treasurer**, a role I've effectively been supporting behind the scenes for years. It's time to pass the torch.

Please welcome **Glenn Rangitonga** as your incoming President. Glenn has given countless hours to the Club and brings calm, practical leadership. I'm confident the Club is in great hands.



#### Recognising Service – Life Member Nominations

The turnaround of this Club has not happened by accident. In 2018, we were on the brink:

- 3 months behind on bills
- Internal conflict on the committee
- Calls to sell the property
- Facing imminent liquidation

Thanks to the generosity of members, including \$100,000 worth of loans from our Patron and members (which we were pleased to pay back with interest within a year) and the extraordinary commitment of our committee, we not only survived, we thrived.

That core group worked tirelessly, hands-on, often behind the scenes, for years. Today, the Club is financially sound, socially vibrant, and the outside areas are now fully licensed — and it's time to formally recognise that effort.
