Treasurers report

- Two Cabins are empty. We need to advertise and get them tenanted. If not tenanted by a certain date (March?) We should sell the vacant one/s.
- Debbie has been chasing the insurance company for business interruption insurance for over 18 months. Finally they have agreed and paid out \$57,000 to the Club.
- Our savings is getting low (\$120,000), it peaked in May 2024 but we have dipped into it for asphalt, kitchen, repairs, bathrooms and bills. We need to build it back up.
- Since April this year we have taken \$90,000 from the savings account including \$10,000 this month, just to pay bills.
- Costs that have gone up:
 - Entertainment expenses are up James Ray is more expensive and we are accounting for the hospitality to Jam night and James Ray now.
 - Electricity and Gas prices are way up. Probably cabin related
 - Removing the non-cash depreciation, year to date the loss is \$75,191 and \$68,000 comes from the kitchen
 - o Income and wages are down on last year but purchases, repairs and maintenance are up in the kitchen.
 - The accountant has advised we need to review the kitchen operation as we can't keep carrying the loss.
